## Members and Building Officials:

SWOBOA is trying to improve its membership and seminar fee system by offering an *"optional"* one-time annual payment that will cover your membership and seminars for the amount of **\$100** for Active members and **\$120** for Associate members. This will also be extended to our Retired and other OBOA Chapter members for the amount of **\$100**. You will have the option to register as you have before.

## Memberships

Active = **\$35**                      Associate = **\$45**                      Retired/Student = **no membership fee**  
Other OBOA Chapter = **\$20** (must be a current paid member)

## Seminars

Active = **\$25**                      Non-members = **\$40**                      Retired/Student = **\$25**                      OBOA = **\$25**

## One Time Fee Option:

Active = **\$100**                      Associate = **\$120**                      Retired/Student = **\$100**                      OBOA = **\$100**

The advantage of the one-time payment is that you will be able to attend all seminars, but those seminars are on a "first register-first serve" basis. You would have to pre-register to every seminar since there is limited seating at the majority of the seminars.

Also with this pre-registration, the rules will change; we may charge you or your jurisdiction the regular seminar fee of **\$25** if you fail to show up for the seminar. This measure has to be in place because if you fail to show, that means there is an empty seat that someone else could have filled. We at the Board wish for you to attend at least 3 seminars.

From time to time, if we see that a seminar would bring more registrants than anticipated, we might offer it (at the discretion of the presenter and availability of the facility) in two sessions, morning and afternoon for that day or move to a larger facility if necessary.

As this is not a change on the by-laws, we feel that this is a Board of Directors policy and therefore the vote to offer this optional method has been discussed among the Directors for the past 3 meetings. The Board of Directors will vote on this issue as a BOD policy on November 18th, after Elections and will show up as a payment option in your renewal form for 2011.
